AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE FUTURE LAND USE MAP OF THE 2030 COMPREHENSIVE PLAN OF THE CITY OF LAKE ALFRED, FLORIDA, BY ASSIGNING THE FUTURE LAND USE DESIGNATION ON APPROXIMATELY 59.20± ACRES TO APPROXIMATELY 33.81± ACRES HEAVY COMMERCIAL/INDUSTRIAL (HC/IND) AND 25.39± ACRES CONSERVATION (CON) FUTURE LAND USE DISTRICTS FOR PROPERTY TOTALING 59.20± ACRES; GENERALLY LOCATED AT 0 DELBERT COLLINS ROAD, NORTH OF OLD HAINES CITY LAKE ALFRED RD, SOUTH OF LAKE LOWERY AND THE CSX RAILROAD, AND EAST AND WEST OF DELBERT COLLINS ROAD, ALSO KNOWN AS PARCELS 262723-000000-024010, 262723-000000-023030 and 262723-000000-042000, LOCATED IN THE GREEN SWAMP AREA OF CRITICAL STATE CONCERN; TRANSMITTING SAID AMENDMENT TO THE FLORIDA DEPARTMENT OF COMMERCE; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; PROVIDING BUSINESS IMPACT ESTIMATE; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
