AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LAKE ALFRED, FLORIDA, BY CHANGING THE ZONING DESIGNATION ON APPROXIMATELY 0.8± ACRES FROM VINTAGE RESIDENTIAL NEIGHBORHOOD (VRN) TO APPROXIMATELY 0.8 ± ACRES NEIGHBORHOOD ACTIVITY CENTER (C-1) ZONING; GENERALLY LOCATED AT 430 N LAKE SHORE WAY, NORTH OF W ALFRED STREET, SOUTH OF W SWOOP STREET, EAST OF N BUENA VISTA DRIVE, AND WEST OF N LAKE SHORE WAY, ALSO KNOWN AS POLK COUNTY PROPERTY APPRAISER PARCEL IDENTIFICATION NO. 262732-503000-009010, LOCATED IN THE DOWNTOWN OVERLAY DISTRICT; TRANSMITTING SAID AMENDMENT TO THE FLORIDA DEPARTMENT OF COMMERCE; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; PROVIDING BUSINESS IMPACT ESTIMATE; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
