AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LAKE ALFRED, FLORIDA; BY ASSIGNING THE VINTAGE RESIDENTIAL (VRN) ZONING DISTRICT ON APPROXIMATELY 14.2± ACRES OF LAND AND THE CONSERVATION (CN) ZONING DISTRICT ON APPROXIMATELY 10.8± ACRES OF LAND TOTALING 25.0± ACRES; GENERALLY LOCATED AT 0-405 FANNIES PATH, 0-525 MAULTSBY LANE, 0-323 CLARK ROAD, AND 319-323 MYERS LANE, FURTHER DESCRIBED AS SOUTH OF LAKE ALFRED ROAD, WEST OF LYNCHBURG ROAD, AND EAST OF LAKE MARIANA. 1. Summary of the proposed ordinance: This ordinance proposes changing the zoning on several parcels of land that were annexed into the municipal boundaries by a special election for the Serdjenian Subdivision.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Lake Alfred if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
