AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LAKE ALFRED, FLORIDA; BY ASSIGNING THE MIXED-USE COMMERCIAL (C-2) ZONING DISTRICT ON APPROXIMATELY 1.97± ACRES OF LAND; GENERALLY LOCATED AT 0 LAKE ALFRED ROAD, FURTHER DESCRIBED AT THE NORTHEAST CORNER OF THE INTERSECTION OF LAKE ALFRED RD AND ADAMS BARN RD, NORTH OF LYNCHBURG RD. INCLUDING PARCEL: 262731-000000-044050; TRANSMITTING SAID AMENDMENT TO THE DEPARTMENT OF ECONOMIC OPPORTUNITY; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.
