## **ORDINANCE NO. 1531-23**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE FUTURE LAND USE MAP OF THE 2030 COMPREHENSIVE PLAN OF THE CITY OF LAKE ALFRED, FLORIDA, BY ASSIGNING THE RESIDENTIAL (RES) FUTURE LAND USE DESIGNATION ON APPROXIMATELY 58.8± ACRES OF LAND AND THE CONSERVATION (CON) FUTURE LAND USE DESIGNATION ON 145.3± ACRES FOR PROPERTY TOTALING 204.1± ACRES; GENERALLY LOCATED AT 0 LAKE LOWERY ROAD AND 0 WHITE ROAD, EAST AND WEST OF WHITE RD AND ARBUTHNOT LN, WEST OF LAKE LOWERY RD, AND EAST OF CR 557 WITHIN THE GREEN SWAMP AREA OF CRITICAL STATE CONCERN INCLUDING PARCELS: 262721-000000-011000, 262721-000000-013000, 262722-000000-041000 AND 262722-000000-042030; TRANSMITTING SAID AMENDMENT TO THE DEPARTMENT OF ECONOMIC OPPORTUNITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. - The proposed ordinance is required to implement a contract or an agreement, including, but not limited to, any Federal, State, local, or private grant or other financial assistance accepted by the municipal government;
- The proposed ordinance is an emergency ordinance;
- The ordinance relates to procurement; or
- The proposed ordinance is enacted to implement the following:
  - a. Part II of Chapter 163, Florida Statutes, relating to growth policy, county and municipal planning, and land development regulation, including zoning, development orders, development agreements and development permits;
  - b. Sections 190.005 and 190.046, Florida Statutes, regarding community development districts;
  - c. Section 553.73, Florida Statutes, relating to the Florida Building Code; or
  - d. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City of Lake Alfred hereby publishes the following information:

1. Summary of the proposed ordinance: This ordinance proposes changing the future land use on a property.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Lake Alfred if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
- (b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and
- (c) An estimate of the City of Lake Alfred regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

There is no direct economic impact on private, for-profit businesses in the City of Lake Alfred from the adoption of this proposed ordinance.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance: There will not be any impact on any local businesses from the adoption of this proposed ordinance.
