AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LAKE ALFRED, FLORIDA BY ASSIGNING RURAL RESIDENTIAL (RR) ZONING DISTRICT ON APPROXIMATELY 3.5± ACRES OF LAND FOR REAL PROPERTY TOTALING APPROXIMATELY 24.86± ACRES ANNEXED INTO THE CITY OF LAKE ALFRED; GENERAL LOCATION: BETWEEN HIGHWAY 557 AND CAMP LAKE WITHIN THE GREEN SWAMP AREA OF CRITICAL STATE CONCERN, AND FURTHER DESCRIBED AS PARCEL 26-27-20-000000-031010; MAKING LEGISLATIVE FINDINGS; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES AND RESOLUTIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS; PROVIDING FOR CODIFICATION; PROVIDING BUSINESS IMPACT ESTIMATE; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. 1. Summary of the proposed ordinance: This ordinance proposes changing the zoning on a property.
