AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF LAKE ALFRED, FLORIDA, BY CHANGING THE ZONING DESIGNATION ON APPROXIMATELY 37.03± ACRES FROM VINTAGE RESIDENTIAL NEIGHBORHOOD (VRN) TO APPROXIMATELY 37.03 ± ACRES MIXED USE CORRIDOR (C-2) ZONING; GENERALLY LOCATED AT 0 HWY 557, WEST OF HIGHWAY 557, SOUTH OF CAMP LAKE, NORTH OF LAKE EVA, EAST OF GRASSY LAKE, EAST, AND NORTH AND SOUTH OF OLD LAKE ALFRED ROAD, AT THE INTERSECTION OF HWY 557, OLD LAKE ALFRED ROAD AND PINE TREE BOULEVARD, ALSO KNOWN AS POLK COUNTY PROPERTY APPRAISER PARCEL IDENTIFICATION NO. 262720-000000-032010, LOCATED IN THE GREEN SWAMP AREA OF CRITICAL STATE CONCERN; TRANSMITTING SAID AMENDMENT TO THE FLORIDA DEPARTMENT OF COMMERCE; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; PROVIDING BUSINESS IMPACT ESTIMATE; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
