AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKE ALFRED, FLORIDA, AMENDING THE OFFICIAL FUTURE LAND USE MAP OF THE 2030 COMPREHENSIVE PLAN OF THE CITY OF LAKE ALFRED, FLORIDA, BY CHANGING THE FUTURE LAND USE DESIGNATION ON APPROXIMATELY 2.53± ACRES FROM CONSERVATION (CON) FUTURE LAND USE TO APPROXIMATELY 0.24± ACRES PUBLIC BUILDINGS AND GROUNDS (PBG) FUTURE LAND USE AND 2.29+/- CONSERVATION (CON) FUTURE LAND USE; GENERALLY LOCATED AT 0 OLD LAKE ALFRED ROAD, WEST OF COUNTY ROAD 557 AND EAST OF OLD LAKE ALFRED ROAD; ALSO DESCRIBED AS POLK COUNTY PROPERTY APPRAISER PARCEL IDENTIFICATION NUMBER 262720-000000-031020; LOCATED IN THE GREEN SWAMP AREA OF CRITICAL STATE CONCERN (GSACSC); PROVIDING FOR THE INCORPORATION OF RECITALS; TRANSMITTING SAID AMENDMENT TO THE FLORIDA DEPARTMENT OF COMMERCE; REPEALING ALL ORDINANCES IN CONFLICT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS AND CODIFICATION; PROVIDING BUSINESS IMPACT ESTIMATE; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
